#### 4. Undertaking:

- a. The Fund will comply at all times with the Protection of Personal Information Act, No 4 of 2013 ("POPI").
- b. The Administrator may be required to collect and share your personal information as well as personal information of your dependants and or nominees, which you have provided to the fund, in investigating and distributing the death benefit.
- c. In instances where the Fund is unable to contact your dependants and or nominees, the Fund may appoint external tracing agents and give them access to your dependants and nominees' personal information in order to do any tracing. If a tracing agent is appointed, a tracing and management fee may be deducted from the benefits payable.
- d. You authorise the Fund's representatives and contracted third party service providers to collect and process certain personal information from your employer or any third party in order to assist the Trustees in making a decision with regard to the distribution of the death benefit.

- a. That this nomination cancels all nominations, if any, that I have made in respect to my membership of the fund;
- b. That the nomination form is not a final Will and Testament but will serve as a guide to the Trustees in distributing the death benefit in terms of section 37C of the Act;

- d. I accept that it is my responsibility to advise my employer should my circumstances change (e.g. child is born, get married or divorced)

#### 6. DISPOSAL OF LUMP SUM DEATH BENEFITS (THIS EXPLANATION IS NOT A LEGAL DOCUMENT- THE WORDING OF THE ACT IS DEFINITIVE)

In terms of the Pension Fund Act, a member's dependants and persons who are not dependants but who are nominated by the member must be taken into cognisance by the Trustees when they decide on how the lump sum benefits are to be distributed upon the death of a member belonging to the registered pension or provident fund.

(Disclaimer: This Nomination Form only applies to (lump sum death benefits payable in terms of the Rules of the Fund. Death benefits are awarded and paid in terms of Section 37C of the Pension Fund Act to dependants, nominees or your Estate.)

### 7. PLEASE LIST YOUR DEPENDENTS AND ANY NOMINEES ON THE OTHER SIDE OF THIS FORM AFTER YOU HAVE READ THE FOLLOWING NOTES:

Briefly, the position is as follows;

- a. If there are dependants and no nominees, payment of the benefit due must be made to one, some or all those dependants in such proportions as the Trustees shall determine
- b. If there are dependants and the member has indicated nominees on this form to receive part or all of the benefit, the Trustees shall determine the proportion which is to be paid to each dependant and the proportion to be paid to each nominee (a nil proportion may be allocated)
- c. Only if there are no dependants, and then only to the extent that payment is not due to a nominee, shall any balance remaining be paid to the deceased member's estate or, where appropriate, the guardian's fund
- d. Trustees have the right to transfer monies to trust or Beneficiary funds, for the benefit of a minor dependant or minor nominee or the guardian
- e. If there are both dependants and nominated beneficiaries, such nomination must have been made on or after 30 June 1989. Nominations made prior to this date are not valid

#### 8. NOTES:

- a. Any income tax payable will be deducted prior to any payment, as applicable
- b. The fact that a person is classified as a dependant or nominee does not mean that the Trustees must award him or her any benefit from the fund
- c. An institution (e.g. an old age home) can be chosen as a nominee
- d. The requirements set out above do not apply to pensions payable to spouses or dependants in terms of specific provisions of the rules, such pensions are payable as described in the rules
- e. The requirements set out above do not apply to Unapproved Group Life Assurance Fund
- f. Prior to 19 April 1996 major children did not automatically qualify as dependants
- g. Any alterations or deletions on the forms must be initialed (abbreviated signature)
- h. The percentage of benefits indicated must total 100%
